COVERT TOWNSHIP BOARD OF TRUSTEES REGULAR BOARD MEETING

Tuesday, June 9, 2020 at 7:00 p.m. Covert Township Hall Via Video Conference

The Regular Meeting of the Covert Township Board was brought to order by Supervisor Palgen at 7:00 PM.

The Pledge of Allegiance to the Flag was led by Supervisor Palgen.

The electronic and telephonic meeting rules were presented by Attorney Seth Koches.

Public Comment

- Rev. W. C. Askew, Sr., Van Buren County Road Commissioner, shared that the Road Commission is working 36 40 hours doing road work county-wide, including ditching. The office is still closed but taking calls. The new director was then introduced.
- Daniel Bishop, Van Buren County Road Commission Director, shared some information about himself, including that he is a long-time resident of Van Buren County.
- Gail Patterson-Gladney, Van Buren County Commissioner District #1, shared information on two grant applications to support public transit and the results of a recent financial audit. The Commissioner also thanked Covert residents who attended the recent Black Lives Matter march in South Haven. Chief Updates

- Police Chief Allen shared the recent seizure of fire arms and drugs in the community that was successful thanks to a tip from a resident. There has also been an increase in traffic enforcement due to the uptick in drugs.
- Fire Chief Myers shared that call volumes are almost back up to normal. Cardiac related deaths in the state are up 30% possibly due to people not

calling 911 during the COVID-19 pandemic. Another new health concern is pediatric inflammatory disease, which is directly related to the virus. Chief Myers also shared that the new full-time hire is doing fantastic, but there are now two openings and they are accepting applications through the 12th of June. The department also completed hose testing and is keeping an eye on shoreline erosion.

- Mike Dambrowski has resigned from the Senior Advisory Committee.

- Supervisor Palgen congratulated the seniors of Covert Public High School for their commencement.
