# **COVERT TOWNSHIP BOARD OF TRUSTEES** REGULAR BOARD MEETING MINUTES Tuesday, May 8, 2018 at 7:00 p.m. Covert Township Hall

### **REGULAR MEETING**

The regular meeting of the Covert Township Board was brought to order by Supervisor Palgen at 7:00 PM.

#### **Public Comment**

- Rev. W. C. Askew Sr., Van Buren County Road Commission Chair, gave informational updates to the Board including culvert repairs and latest quote to resurface CR376.
- Resident of Public Housing shared concern over fence that was installed to block a pathway that leads from the Public Housing residence to the parking lot of the Fire/Police Complex.
- Barbara Norman, resident of Covert Township and Public Housing Commission member, asked for clarification of who owns the land where the pathway is.
- Barbara Richmond, resident of Covert Township, asked if the board had any recommendations for general contractors to help her with a house remodel.
- Ella Harrington, resident of Covert Township, also asked for clarification on the fence blocking the Public Housing pathway and what the Township plans to do with the vacant buildings downtown.
- Resident of Public Housing asked for further clarification on who is responsible for paying for the pathway and who is liable for any injuries.
- Barbara Norman, Public Housing Commission member, shared that the commission was never presented with a proposed new pathway and urged the board to speak with the commission regarding the issue.

## **Chief Updates**

• Fire Chief Myers presented an update on the Fire Department, including the current risk of grass fires, the acquisition of donated radios, training sessions

hosted in Covert, NFPA's new requirements regarding Active Assailant drills, and a blood drive/health fair hosted at the Covert FD on May 23<sup>rd</sup>.

• Police Chief Allen shared the department's latest efforts in battling the opioid epidemic, including informational meetings and counseling hosted at local churches.

## **Dangerous Buildings - Orders to raze**

Supervisor Palgen addressed the following properties individually and gave property owners an opportunity to address the board.

 Case 2018-02, Alicia Woodruff-Hernandez, 71123 28<sup>th</sup> Avenue: Hearing Officer David Leroy ordered the demolition of the single wide storage trailer by April 17, 2018. Demolition has not been completed as of 04.18.2018. *Property owner was not present for comment.*

- Case 2018-04, Mitchell Cichy Jr., Unaddressed, CR-376: Hearing Officer David Leroy ordered the house and shed be demolished, the bus be removed and the well pit be decommissioned capped. Demolition has not been completed as of April 18, 2018. *Mr. Cichy was present and has since demolished the condemned house, removed the bus and kept the well as it is operable. He wants to keep the shed as storage. Photos were shared.*
- Case 2018-05, Margaret Russell, 40214 76<sup>th</sup> Street: Hearing Officer David Leroy ordered the house and sheds (outbuildings). Demolition has not been completed as of April 18, 2018. *Son was present and asked for a 30 day extension to complete the demolition*.
- Case 2018-06, Curly Fletcher, 41909 M-140 Hwy: Hearing Officer David Leroy ordered the demolition of the building (black and white trailer) and garage. Demolition has not been completed as of April 18, 2018. *Property owner not present for comment*.
