COVERT TOWNSHIP BOARD OF TRUSTEES REGULAR BOARD MEETING MINUTES

Tuesday, November 10, 2020 at 7:00 p.m. Covert Township Hall & Electronic Component

The Regular Meeting of the Covert Township Board was brought to order by Supervisor Palgen at 7:00 PM.

The Pledge of Allegiance to the Flag was led by Supervisor Palgen.

Electronic and Telephonic Meeting Rules

Attorney Roxanne Seeber explained latest amendments to the Open Meeting Act allowing for virtual meetings with certain restrictions through the end of December 2020 or December 2021 with the adoption of a policy.

Public Comment

- Gail Patterson-Gladney, Van Buren County Commissioner District #1, shared the latest news from the County, including a \$200,000 grant and changes to the domain and website. A preserve owned by Van Buren County has been leased to the MDNR to be managed as part of the Van Buren State Park in South Haven.
- Ken Harrington, Covert Township Board Trustee, congratulated the new board members and thanked voters for allowing him to serve another four years.
- Barbara Norman, Covert Resident, made comments about the Covert Park
 Beach and Campground, including the net revenue and letting residents know
 that they have free access. Ms. Norman was displeased with the method to
 prove residency.
- Dennis Palgen, Covert Township Supervisor, thanked the Van Buren Road Commission for the sewer and drain repair on West Street and 34th Avenue and seal coating CR 376 east of M 140.

• (Late Arrival) Rev. W. C. Askew, Sr., Van Buren County Road Commission, shared that more road millage funds will be available for Covert. The office is open from 7AM – 3:30PM. They are still doing Zoom meetings and are getting trucks ready for winter weather.

Chief Updates

- Police Chief Allen shared that traffic enforcement has been increased due to recent tragedies, especially at stop signs on side roads. Citizens are asked to provide any information on activity in the southwest corner of the Township, as well as names of seniors and any special needs residents who may need a wellness check during an outage as we enter winter weather. The department has also been busy recovering stolen property and working with the State Police on a cold case homicide. Chief Allen thanked the board and public for their support during his recent personal tragedy. L. Taylor asked about the increase in complaints and D. Palgen asked about the plan if jails don't reopen soon.
- Fire Chief Myers shared that they have finished flushing over 300 hydrants and have been busy with several grass fires. Burn permits are free and do not leave fires unattended. Training of new hires is nearly complete.

- A realtor who specializes in industrial buildings used for flocking has two interested buyers for a building for sale in Covert Township.
- Covert Township Attorney, Roxanne Seeber, presented information on the status of West Michigan Flocking and Assembly, LLC. The Township is aware the that West Michigan Flocking & Assembly, LLC still has an Industrial Facilities Tax (IFT) Exemption Certificate in effect; the company has ceased operations and the building is up for sale. The Township Board is prepared to take action, if necessary, at the December 8, 2020 Regular Township Board Meeting.
