# COVERT TOWNSHIP BOARD OF TRUSTEES REGULAR BOARD MEETING MINUTES

Tuesday, April 9, 2019 at 7:00 p.m. at Covert Township Hall

#### REGULAR MEETING

The regular meeting of the Covert Township Board was brought to order by Supervisor Palgen at 7:00 PM.

The Pledge of Allegiance to the Flag was led by Supervisor Palgen.

## **Public Comment**

- Rev. W. C. Askew, Sr., Van Buren County Road Commissioner, shared insight on proposed gas tax and a meeting with Covert Township on May 8<sup>th</sup> regarding road repair projects. Rev. Askew also gave an update on Covert services.
- Gail Patterson-Gladney, Van Buren County Commissioner District #1, shared latest news from the County, including a medication "Take Back" day in South Haven, the hiring of a Chief Public Defender, and an upcoming speaker event on affordable housing on April 11.
- Dorothy Holmes, Covert Township resident, asked whether the restrooms in the Township Hall are A.D.A. compliant and to explain why there is a clearing of trees throughout the area.
- Carol Sage-Stewart, Covert Township resident, asked if the Township Board could begin using microphones for the hard of hearing and to repair the large holes near the cross pipe repair on 34<sup>th</sup> Ave.

### **Informational Update**

Supervisor Palgen shared the following information to the public:

- Several Township employees and officials took a tour of the roads with members of the Road Commission to identify areas in need of repair and maintenance.
- A draft application to the U.S.D.A. for a grant to help maintain our waste water system will be available soon. Fleis and VandenBrink has been contracted to complete this.

- A meeting was held with Park Advisory members and Township Officials to renegotiate a contract with Olson Brothers to begin constructing the washroom facility at the Covert Park Beach and Campground in September.
- A community survey is now available online to be completed by people with interest in Covert Township. Deadline is May 15.

## **Chief Updates**

- Police Chief Allen shared that a new officer has been hired to fill one of two vacancies and there has generally been a decline in incidents, including stray dogs.
- Fire Chief Myers shared the arrival of a new fire engine and that the back-up ambulance has been taken out of commission. Chief Myers is looking into borrowing an ambulance until the new one is in service. Also, a Spanish CPR class is being prepared for the community and the "Stop the Bleed" program is continuing.
