## COVERT TOWNSHIP BOARD OF TRUSTEES REGULAR BOARD MEETING

# Tuesday, June 14, 2020 at 7:00 p.m. Covert Township Hall Via Video Conference

The Regular Meeting of the Covert Township Board was brought to order by Supervisor Palgen at 7:00 PM.

The Pledge of Allegiance to the Flag was led by Supervisor Palgen.

The electronic and telephonic meeting rules were presented by Attorney Seth Koches.

#### **Public Comment**

- Rev. W. C. Askew, Sr., Van Buren County Road Commissioner, shared that there is a 32% reduction in their revenue budget due to COVID-19. The office is now open and regular roadside work has begun, including dust control.
- Gail Patterson-Gladney, Van Buren County Commissioner District #1, shared information on new contracts with the County Sherriff's Department and Veteran's Services, such as health and dental care through the Van Buren/Cass Health Department. Call 1-800-210-1921, and press 0 to make an appointment. 2020 marks the 30<sup>th</sup> Anniversary for the Americans with Disabilities Act and will be celebrated online Friday, July 24th at 11:45 1:30.
- Nick Culp & Mick Middaugh of Entergy Nuclear gave a plant update.
  Palisades Nuclear has been operating for 349 consecutive days at 100% power
  with no expected down time until the upcoming outage. Mr. Culp shared
  COVID-19 mitigation strategies. Spring 2022 is the scheduled closure that has
  been licensed to another company for decommissioning. Fuel will be stored
  on site due to restrictions in moving it to a repository.

#### **Chief Updates**

• Police Chief Allen introduced the newest hire, Officer Metz, who started on the road Monday. Overall, there has been an increase in complaints. Recent

arrests have helped shut down a large drug operation. There have also been a lot of calls that have led to hot spots and people of interest. They have been taking guns off the streets and increased traffic enforcement. Covert is now down to #6 in dog complaints.

• Fire Chief Myers shared that it has been a busy month with 51 calls and an increase in COVID calls. They have implemented a new hiring process to fill two positions and have an increase in applications. They have also been keeping an eye on shore erosion, and shared information on their response to a recent strong storm with a special thank you to the Covert Department of Public Works for their help in moving trees. Chief Myers also shared information on Pediatric Inflammatory Disease on the east side of the state and dangerous hand sanitizers from Mexico that contain methanol. A 911 Millage on the ballot in August was also shared.
