### REGULAR BOARD MEETING MINUTES Tuesday, June 12, 2018 at 7:00 p.m. Covert Township Hall

#### **REGULAR MEETING**

The regular meeting of the Covert Township Board was brought to order by Supervisor Palgen at 7:00 PM.

The Pledge of Allegiance to the Flag was led by Supervisor Palgen.

#### **Public Comment**

- Rev. W. C. Askew Sr., Van Buren County Road Commission Chair, gave an update on culvert repairs and answered questions on the payment and progress of ditching, cleaning out a culvert on Orchard Street, and other road updates.
- Dorothy Holmes, Covert resident, asked how traffic is able to pass through 34<sup>th</sup> while it is closed.
- Gail Patterson-Gladney, Van Buren County Commissioner District #1, congratulated a new graduate of the KVCC Police Academy, and shared information on a tax refund due to New Covert Generating, a Marijuana enforcement grant and the economic health of the county.
- Nick Culp, Government Liaison from Entergy, shared 75 days since the last scheduled outage.
- Dan Seibert, candidate for Michigan State Representative, introduced himself and shared his mission.

### **Guest Speaker**

Luke Miller of West Shore Services, Inc. and William Cable Jr. of Entergy Nuclear, presented the board with a plan to move a digital repeater (digipeater) owned by Entergy that is currently housed at the old Fire Department building. The repeater would be installed at the top of the water tower in Covert Township, with a gas back-up generator installed just west of the tower. The repeater is a part of a redundant alarm system that alerts the public in the event of an emergency. West Shore Services would perform the move and installation.
