Discussion on 2019/2020 Fiscal Year Budget

- Fund revenue/expenses by department were presented by M. Rendell. This included rough projections for the next four years with the decrease in revenue due to Entergy Power Plant closing. Opportunities for cost savings, and how to foresee capital outlay costs was also discussed. L. Taylor urged that Department Heads need to play an active role in devising a plan to save money by having a "needs" list versus a "wish" list. D. Palgen urged that Trustees examine bills before each board meeting.
- Special Funds, such as the Museum and Campground, can be set up as self-supporting.
- Computer replacement costs were discussed.
- Insurance Contributions/In Lieu of Insurance costs were discussed for both union and non-union full time employees and officials.
- The AccuMed Fee Schedule was discussed and recommended rates shared.
- D. Cook presented the recommended Transfer Station Fee Schedule to cover costs to maintain the service.
- The Cemetery Fee Schedule was shared and no changes were recommended.
- Building/Zoning/Plumbing/Mechanical Permit Fee Schedules were discussed. L. Fogarty presented SAFEBuilt as a possible service to explore. This would provide 10% 20% revenue back to the Township to cover administrative costs.
- The new F&V Operation and Maintenance Agreement with a cost of living increase was presented by D. Palgen.
- Discussion was had on exploring other legal services. Prices for a recommended law firm were shared.
