COVERT TOWNSHIP BOARD OF TRUSTEES REGULAR BOARD MEETING MINUTES

Tuesday, April 14, 2020 at 7:00 p.m. Via Video Conference

The Regular Meeting of the Covert Township Board was brought to order by Supervisor Palgen at 7:00 PM.

The Pledge of Allegiance to the Flag was led by Supervisor Palgen.

Motion by K. Harrington, seconded by D. Cook, **to approve** adopting Covert Township Policy 2020-01 Electronic and Telephonic Meeting Rules as presented.

Public Comment

Rev. W. C. Askew, Sr., Van Buren County Road Commissioner, gave an overview of what the Road Commission has been doing during the COVID-19 orders. Offices are closed but calls are still being answered and workers are laying gravel and fixing potholes. The public can use Click N Fix to report issues remotely. Rev Askew praised the new manager and addressed an issue on 34th and West in Covert.

Gail Patterson-Gladney, Van Buren County Commissioner District #1, thanked the township and residents for their efforts in decreasing the spread of COVID-19 and shared information on a Mental Health Warmline to be used for non-emergencies. Anyone struggling with mental health issues can call (888) 733-7753.

Chief Updates

Police Chief Allen shared the new hire of an officer who started Monday and warned the public of a variety of scams impersonating COVID-19 charities, utility workers and the IRS, among others.

Fire Chief Myers has no information on how many COVID-19 positive patients they serve as they do not yet have the ability to test, however they now have the ability to video conference with a patient's doctor to decrease possible exposure. Chief Myers also shared that they passed a state EMS inspection. He spoke at the Palisades Symposium and Jed Wild spoke at the MI Tactical Officers Association

and the Fire Instructors Conference. Chief Myers shared that they currently have enough supplies and explained the process to mitigate exposure when responding to a possible COVID-19 positive patient.

Informational Updates

Supervisor Palgen shared that three cross-pipes and two catch basin pipes at 34th and West Street have failed and may require complete intersection reconstruction. Also, as of April 6th there is no word yet on the oral arguments with New Covert Generating.
